- Minister of Education Resolution No. (30) of 2023 concerning admission standards for bachelor's programs in higher education institutions;
- Ministerial Resolution No. (1) of 2024 concerning the organizational structure of departments, divisions, and their roles in the Ministry of Higher Education and Scientific Research;
- In pursuance of public interest,

Resolved:

Article (1)

Higher education institutions shall establish admission standards for their programs at the bachelor's, higher diploma, diploma, partial qualifications, and short cycle tertiary education levels (levels 4 and 5 in the National Qualifications Framework). They may refer to the standards attached to this resolution for guidance.

Article (2)

The Undersecretary of the Ministry is authorized to issue decisions, circulars, and executive guidelines necessary for implementing the provisions of this resolution.

Article (3)

Minister of Education Resolution No. (30) of 2023 concerning admission standards for bachelor's programs in higher education institutions is hereby repealed, along with any provision that contradicts or conflicts with this resolution.

Article (4)

This Resolution shall be published in the Official Gazette and shall be effective on the following day of its publication.

General Guidelines:

- 1. All levels of academic degrees must align with the National Qualifications Framework of 2024. Admission to master's or doctoral levels requires the preceding qualification level.
- 2. The indicative secondary scores mentioned are based on the UAE Ministry of Education's Advanced Track curriculum or equivalent standards.
- 3. Universities are not required to set a minimum overall secondary score.
- 4. Students from non-UAE Ministry of Education curricula taught in English are not required to prove English proficiency.
- 5. Students from non-English curricula must prove English proficiency through international standardized tests as determined by the university.
- 6. Students from non-UAE curricula must demonstrate proficiency in relevant subjects as determined by the university.
- 7. Universities may conditionally admit students, requiring them to complete preparatory or remedial programs.
- 8. Fields other than Medicine, Dentistry, Pharmacy, Engineering, and Law do not require specific minimum subject scores.
